IMPORTANT INFORMATION FOR ESTIMATED TAXPAYERS

It is the taxpayers responsibility to maintain the accuracy of the declaration of income by amending the estimated tax due as required by changing circumstances.

A declaration of estimated tax for the current year must be filed on or before the due date of the final return for the previous year accompanied by a payment of at least 22.5% of the estimated tax. At least a similar amount shall be paid on or before July 31, October 31 and January 31 of each year.

(FISCAL YEAR TAXPAYERS WILL SUBSTITUTE THEIR CORRESPONDING DATES)

An assessment will be made if you have not paid at least 90% of the actual tax due by the end of the thirteenth month after the start of the fiscal year or, alternatively, at least an amount equal to the amount paid for the prior year based on a twelve month-period.
