  - o Current State of Ohio Workers Compensation Certificate

## BOND REQUIREMENTS FOR CONTRACTOR REGISTRATION SUBMISSION

- ☐ Comply with City of Brook Park Ordinance Chapter 1311
- ☐ **Separate** Bonds are REQUIRED for each Registration Type (*General, Electrical, Roofing, Cement etc.*)
- ☐ Bond shall be in the penal sum of twenty-five thousand dollars (\$25,000)
- ☐ Complete calendar year specific Bond form provided (*Standard Issuance and/or Continuation Certs NOT accepted*)
- ☐ ORIGINAL copy must be submitted, and include: **BOND MUST BE ON THIS FORM**
  - o Inked signatures - Insurance Company & Business OWNER (*Typewritten names NOT accepted*)
  - o Original Insurance Company Seal (*Electronic, Embossed, Foil or Stamped seals accepted*)

The conditions of this obligation are such that, whereas, the above named principal did on this day

Contractor in the City of Brook Park, under the pursuant Ordinance No. 8611-1999, which is made a part of this bond by reference. Now if the said Principal shall receive from the Building Commissioner a registration as a Contractor, entitling him to engage in work or, or act as a

Contractor, in the City of Brook Park and shall fully comply with the provisions of the Ordinances, Resolutions, Building Code and Regulations of the City guaranteeing full and faithful compliance thereto and binding the surety thereon to correct or abate any violations whenever the applicant named as principal on such bond refuses, neglects or fails to correct or abate within a reasonable time limit set by the Building Commissioner. This bond shall indemnify the City and all City Employees from injuries or damages arising by reason of the applicant's negligence or failure to properly perform work undertaken. Where any opening is made or material is placed in the street or highway, the Contractor shall remove any material remaining and replace and restore, or cause to be replaced and restored, the street or highway and the pavement over such opening, to as good a state and condition as found prior to the opening of the same, or pay the City for having same replaced and restored, as the case may be. If the Contractor fails to conform to these obligations, then the Bond shall be void ab initio. This bond shall remain in effect for the following period of time:

It is being expressly understood that the liability of the surety for any and all claims hereunder shall in no event exceed the penal amount of this obligation as herein stated. work shall not in any manner operate to release of discharge the surety from its liability under this bond
