**AN ORDINANCE  
AUTHORIZING THE MAYOR TO ENTER INTO AN  
AGREEMENT WITH GOVDEALS.COM,  
FOR THE PURPOSE OF AUCTIONING MISCELLANEOUS COMPUTER EQUIPMENT,  
AND DECLARING AN EMERGENCY**

**WHEREAS**, the City of Brook Park needs to dispose of miscellaneous computer equipment; and

**WHEREAS**, GovDeals.com provides services to various government agencies that allow them to sell surplus and confiscated items via the internet; and

**WHEREAS**, it is in the best interest of the City of Brook Park that we enter into an agreement with GovDeals.com.

**NOW THEREFORE BE IT ORDAINED**, by the Council of the City of Brook Park, State of Ohio, that:

**SECTION 1:** The Mayor is hereby authorized and directed to enter into an agreement with GovDeals.com, for the purpose of auctioning miscellaneous computer equipment as listed in Exhibit "A" attached hereto.

**SECTION 2:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3:** This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to provide for an agreement between GovDeals.com, and the City of Brook Park; therefore this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
