

**SPECIAL COUNCIL MEETING
OF THE COUNCIL OF THE CITY OF BROOK PARK, OHIO
HELD ON TUESDAY, MAY 9, 2017**

The meeting was called to order by Council President Astorino at 8:45 p.m., who read the notice. The clerk called the roll and the following Members of Council responded:

THIRD READING OF ORDINANCES AND RESOLUTIONS:

Ms. Horvath explained that a recent memo distributed about not being able to have legislation in two places at the same time was an error and could be discarded.

1. ORDINANCE NO. 10075-2017, AMENDING CHAPTER 131.01 OF THE BROOK PARK CODIFIED ORDINANCES ENTITLED 'SALARY' AND DECLARING AN EMERGENCY. Introduced by Councilman Troyer.

Motion by Mr. Scott, supported by Mr. Burgio, to adopt.

ROLL CALL: AYES: Troyer, Powers

NAYS: McDonnell, Mencini, Scott, Burgio. The motion failed with a vote of 2-4. Ordinance No. 10075-2017 is defeated.

2. ORDINANCE NO. 10076-2017, AMENDING CHAPTER 137.01 OF THE BROOK PARK CODIFIED ORDINANCES ENTITLED 'SALARY OF THE FINANCE/TAXATION DIRECTOR' AND DECLARING AN EMERGENCY. Introduced by Councilman Troyer.

Motion by Mr. Troyer, supported by Ms. Powers, to adopt.

ROLL CALL: AYES: Troyer, Powers

NAYS: McDonnell, Mencini, Scott, Burgio. The motion failed with a vote of 2-4. Ordinance No. 10076-2017 is defeated.
