SECOND READING OF ORDINANCES AND RESOLUTIONS:

1. RESOLUTION NO. 23-2018, DECLARING THE AMOUNT OF TAXES THAT MAY BE RAISED BY A LEVY WITHIN THE TEN (10) MILL LIMITATION AND WITHOUT A VOTE OF THE ELECTORS IN THE CITY OF BROOK PARK TO BE INSUFFICIENT AND DECLARING AN EMERGENCY. Introduced by Mayor Gammella and Council as a Whole

Mr. Cingle stated everything that needed to be filed is filed and this legislation can be passed this evening.

Introduced by Mayor Gammella and Council as a Whole

Mr. Salvatore doesn't think any amendments should be made until Council agrees on the exact dates because the contract also has conflicting dates; this has to be perfect.

Mrs. Horvath commented both of these pieces, the legislation and contract, was sent over by Southwest General Counsel, in a word document. It does appear there are some conflicts and this might be a good time to take a short recess to review.

Mr. Mencini commented on line 14, the dates are 2014 to 2019.

Mr. Salvatore commented there are conflicting years in the contract, also.

Motion by Mr. Salvatore, supported by Mr. Burgio, to take a five-minute recess to review the legislation and contract.

Mr. Mencini asked if Mayor Gammella has talked to the city engineer about what streets would be included in this crack sealing project?

Mayor Gammella stated the city engineer is currently out of the country.

Mr. Orcutt stated this is going to be very helpful in creating preventive maintenance for the roads.
