Southwest General Health Center - Trustee, Salvatore

Mr. Salvatore reported the first year turnover rate is at 15% and overall turnover rate is down to 12%, better than target. Nursing services staff celebrated providing high-quality safe patient care. The main surgery center as well as the Big Creek surgery continue to be above budget from last year. There is \$5.3 million-dollars approved for the budget along with \$20 million-dollars for capital. The Family Physician practice will continue to be a part of Southwest General and LifeWorks is celebrating 20-years of service providing health and wellness. The Lakefront Group notified Southwest has once again received an A-grade in the LeapFrog Safety, a gold standard for patient safety among hospitals across the country. Southwest has also been recognized for Medicare and Medicaid services as a five-star hospital and the Southwest Police Department was recently formed. The next board meeting will be held on May 1st.

# Aviation and environmental report 4/16/2019

The aviation and environmental committee has no items on tonight's agenda. However, there are a couple items to speak about.

- There will be a rain barrel workshop held in here in the rec center tomorrow, 4/17/2019 from 6:30 – 8:00pm. The workshop is sponsored by the city of brook park, the cuyahoga soil and water conservation district, and the rocky river watershed council. Pre registration was required by 4/10 to attend the workshop
- There has been no news as to when the environmental design group is meeting with the city of
  cleveland to discuss granting an easment for the potential abrams creek project. I will reach
  out to them this week to see where they are on that front
- I received a call from a resident who was complaining about a neighbor burning wet wood and leaves. Chapter 1511 of the brook park codified ordinances deals with "open burning". I urge our residents who engage in burning to look over that ordinance to familiarize themselves with it. But here are some key points in that chapter
  - Only seasoned firewood shall be burned in outdoor fireplaces and chimeneas;
  - no rubbish, green wood or treated wood, painted wood, stained wood or pallets will be permitted to be burned;
  - Flames shall not be higher than the components of the fireplaces
  - An adequate fire extinguisher (one extinguisher with a minimum 4-A rating or two extinguishers with a minimum 2-A rating) or garden hose is required to be readily accessible in close proximity to the fire
  - If wind direction causes smoke to be a nuisance to the public, the fire will be required to be relocated or extinguished. The Fire official has the right to determine if wind conditions pose a hazard requiring fires to be extinguished

-There is a lot more to chapter 1511, so I again urge anyone who likes to burn, to please read up on this ordinance. And I also urge you to be courteous to your neighbors and only burn appropriate materials. "green or wet" wood and leaves creates a lot of smoke, and it can be a nuisance to your neighbors.

After listening to the school's staff, the community and the board of education, we unanimously decided to open the elementary school to students in August 2020, at the beginning of the school year. - 7. There will be a "progress as promised" meeting on Wednesday, May 1<sup>st</sup> in the BMHS auditorium to update the public on the progress of the construction projects within the district
