## **DISCUSSION:**

1. CLASSIC MAZDA REPRESENTATIVE - **In attendance:** Jim Brown, CEO and Owner of the Classic Auto Group.

**Motion** by Mr. Scott, supported by Mr. Orcutt, that item number one was discussed.

2. PROPOSED AMENDMENT TO COUNCIL RULE NO. 2 - MEETINGS PUBLIC - EXECUTIVE SESSION. (Councilman Troyer)

Mrs. Horvath noted the way this is written, doesn't think there will be discussions on Hospital Trade Secrets or Veterans' Service Commissions applications. Those are listed in the Sunshine Laws for other boards and commissions and wouldn't pertain to city business that exists now.

3. A RESOLUTION HONORING ROSIE'S PLAYHOUSE AND DECLARING AN EMERGENCY.

**Motion** by Mr. Mencini, supported by Mrs. Schmuck, to place back in committee. **ROLL CALL: AYES:** Mencini, Schmuck, Scott, Orcutt, Troyer, Poindexter, Salvatore **NAYS:** None. The motion carried.

Mr. Troyer asked if item number three legislation was introduced?

Mr. Vecchio responded introduced at the March 17th Council meeting.

Mr. Troyer continued a call was received from a resident after last week's special meeting. To the law director since the legislation that appeared on that agenda were not read in their entirety. This discussion has come up before since the legislation was posted on the agenda of Council they didn't need to be read; from past legal opinions want to clarify it was done correctly at the last meeting.

Mrs. Horvath clarified the April  $14^{th}$  special meeting all legislation was posted as well as the special meeting held on April  $13^{th}$ .

The clerk concurred legislation appearing on both special agendas were properly posted.

Mrs. Horvath stated since legislation was posted both on April 13<sup>th</sup> and 14<sup>th</sup>, that would be sufficient and in full compliance in what needs to be done.

4. MEETING CRITERIA FOR COVID-19 – (Council President Vecchio)
Mr. Vecchio stated this has been discussed and this evening's videoing over Zoom is one of the steps in place as well as teleconferencing. Members from different departments can also be part of the teleconference calls and/or video as being done now.

Mr. Poindexter suggested due to a few glitches perhaps the technology committee could be consulted to have meetings run smoothly; they have ideas that will help streamline the process.

Mr. Vecchio stated that would be through the Mayor's office, the glitches in the first setups is due to Boxcast, the company that does the livestreaming, literally just provided set-up instructions yesterday, Due to livestreaming with a separate entity Zoom is setup initially with livestream capabilities going to Facebook and You-tube; unfortunately, You-tube is editable and not something of a preferred area. Boxcast cannot be edited and have been working on this for two weeks to get where we are now, open for any ideas for streaming easier.

Mr. Poindexter interjected based on several discussions with tech-committee members they can get this to flow fluently without issue; reached out about one week ago saying it was compatible.

Mr. Vecchio stated have the committee put forth information to the Mayor and all of Council.

Mr. Mencini stated agreement with the tech-committee have good backgrounds and they could have looked at through this process. Along, with other things i.e. city email, city phones and livestream, a lot of these issues should have been done by

now. Not putting this on anybody but that committee is savvy with what they do and think it would be worthwhile to see what their ideas are and if they can offer what can be done with the livestream.
