New Legislation:

1. REQUEST FOR THE LOT SPLIT OF THE PROPERTY LABELED AS PARCEL NO. 1 (ONE) LOCATED AT 16900 HOLLAND ROAD 'BROOK PARK MEMORIAL'; IN THE MUNICIPAL AND BOARD OF EDUCATION ZONE FROM THE PROPERTY LABELED AS PARCEL NO. 2 (TWO), PARCEL NO. 3 (THREE) AND PARCEL NO. 4 (FOUR) LOCATED AT 17001 HOLLAND ROAD 'BROOK PARK ELEMENTARY' IN THE MUNICIPAL AND BOARD OF EDUCATION ZONE AND REQUEST THE CONSOLIDATION OF THE 18.1595 ACRES LABELED AS PARCEL NO. 1 (ONE).

Motion by Mr. Troyer to introduce and also a motion to place under letter M using emergency rule #12f, second paragraph. There is no letter M.

Mr. Vecchio responded no, also legislation needs to be drafted. This meeting is to request legislation for this lot split and consolidation.


