1. DIVISION OF LIQUOR CONTROL - Brookpark Sunoco, Inc. 6313 Engle Road, Brook Park, OH 44142. **C New 0976874 - C2**  
**Postmark Date: 11/29/2021.**

Mrs. Horvath stated this appears to be for a new license and the department will be contacting the business and doing some due diligence because of the location.

Mr. Mencini asked if there are any problems that Council is not aware of?

Mrs. Horvath responded this may be a different type of alcohol beverage that the establishment currently has now. The permit is marked as a C-2 and looking at the permit classes that is for mixed beverages for carryout. Will confirm for Council what sort of license the establishment currently has and why the establishment the desire for this new type of license.

Mr. Troyer stated this permit is to add wine to the establishment. Doesn't include Sunday wine, there is a different spot for that. This is to sell wine along with the beer the owner currently sells.

Mr. Vecchio clarified with Mrs. Horvath that more information will be coming to Council on this matter?

Mrs. Horvath responded, yes, always think that it's important that Council have some background information as to why the license is being requested and what the requester hopes to accomplish. As well as making sure it's appropriate by doing due diligence and background checks.

Mr. Scott stated the first page states response must be postmarked no later than November 29, 2021. Should we ask for an extension?

Mr. Vecchio asked Mrs. Horvath because of this being currently a Vapor or Hookah lounge. If this permit is granted would that establishment have to go to a bar-restaurant?

Mrs. Horvath responded that's an interesting question, and one of the people to be consulted, in this case, would be the health department for some idea of restrictions and rules the department has for this type of business.
