Mr. Scott stated speaking with Madam Coyne I was informed that she wants to get together with other Councilmembers about the new piece that is all-inclusive, dealing with both the dispensary and zoning.

Mr. Poindexter stated speaking with Madam Coyne yesterday, she is 100% comfortable with these moving forward, and can amend.

Mr. Troyer stated have had no conversations about these two pieces of legislation and doesn't know what changes could be made.

Mr. Mencini stated there has been plenty of time to make amendments and am fine with Madam Coyne making them next week.

Mr. Salvatore stated if that conversation happened with my colleagues I'm fine with moving forward.

Mr. Roberts concurred, this has been going on long enough any amendments can come forward.

## **SAFETY COMMITTEE - CHAIRMAN, ROBERTS:**

1. A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN ALL-HAZARDS MITIGATION PLAN WITH CUYAHOGA COUNTY, AND DECLARING AN EMERGENCY. Introduced by Mayor Orcutt & C/W.

Mayor Orcutt this should be done every five years; this plan is part of FEMA (Federal Emergency Management Agency) and helps the city for applying for federal grants.

Mr. Salvatore stated legislation speaks for itself and it's important for the city to participate.

Mr. Troyer offered an amendment to section 1 to delete the words 'and as amended in the future'.

Mayor Orcutt advised Council these disaster mitigation plans will change and there are items that may have to be changed in the future.

Mr. Salvatore stated if that change is made the city may not be a participant in this program.

Mr. Vecchio stated meant to be a fluid document when matters occur such as Covid-19; tornados or natural disaster. If that is removed that would be tying the city's hands and have to go through the legislative action to make those changes.

Mr. Troyer asked Mrs. Horvath will this be an all-inclusive forever or will a new plan be coming forward in 2028. .

Mrs. Horvath responded this is a reoccurring process and in 2028 Council will be going through the same. Wished the law department was contacted before the meeting could have an answer for Council. Suggested foregoing any amendments until the law department can make that determination.

Mr. Troyer stated the City of Middleburg Hts. Passed this without that language and

if Mrs. Horvath believes a new plan will be coming in 2028 I'm fine with this.

Mr. Poindexter asked if any costs are associated with this. Mayor Orcutt responded no.

Mr. Poindexter expressed concern with the agreement possibly being amended to add costs without Council approval.

Mayor Orcutt responded there has never been a cost associated in the past it's just the city adopting this mitigation plan for FEMA matters, making sure if there is a disaster every county has a plan.

Mr. Troyer stated the problem not seeing the 2022-2027 agreement and would like to know that the agreement Council is entering into.
