The Rocky River Watershed Council will be having a tree planting event this Saturday at 11:00 a.m. at Konery Park, looking for volunteers.

Service Director Beyer

Mr. Bever reported bulk pickup is next week on regularly scheduled rubbish day for residents' only, mattresses, box springs and cloth furniture must be wrapped; no contractors should be dumping bulk items on tree lawns. If residents are bringing bulk items to the service garage please bring proper identification. The garage is open for yard waste and rubbish drop-off until November 19th from 7:00 a.m. to 7:00 p.m. and Saturdays from 10:00 a.m. to 2:00 p.m. This year the department is trying something new by staying open on Saturdays only from 10:00 a.m. to 2:00 p.m. for rubbish and yard waste drop-off. October 15th is Shred-it day from 10:00 a.m. to 1:00 p.m. for residents' only. Leaf pickup will begin when an abundance of leaves begins to fall, make sure there is no dog waste, other debris or sticks this may cause the leaf pile to not be picked up.
