#### **Questions:**

Madam Coyne thanked Mayor Orcutt and American Legion Post #610 for the wonderful dinner for the veterans. Onto to business, last week the HMAP report was received and I now understand status of this not forthcoming, due to this program being a complete failure. There were 22 applicants and the city is giving away monies and it seems nobody qualifies. We need to improve with communication on the city's website and possibly the property maintenance inspector could inform violators about this program. I think this legislation should be re-evaluated and must eliminate the match, income restrictions and listed maintenance requirements. I will be forwarding legislation to the law department because residents need to be informed about this program and we need to do better with this program.

Mayor Orcutt requested to respond immediately especially when hearing complete failure, which is a negative comment to this administrative. Also, want to explain and reiterate that this legislation was introduced in April, after budget passage, with many amendments coming forth including some from Madam Coyne that held up this legislation. I spoke to this Council that with the amendments being made that would limit the contractors and was told that wouldn't be a problem by a Councilperson and that is exactly what has happened. Being in the industry for 30 years I know how things work and there are not enough trades people to fulfill the jobs. So residents trying to get three quotes starting in July and August the contractors are meeting jobs that were scheduled in the winter months, for the

upcoming season. Just a note there were 52 applicants that came to City Hall with only 22 being allowed due to residents not being able to re-apply with the seven (7) years requirement. The economic development commissioner works hard with these residents and also works with the building department on mailing out or driving applications to residents' homes and also working with residents with the needed quotes. With advertising the property maintenance inspector provides the application and information to the residents about this program.

Mr. Poindexter asked for an update status on Wedo Park?

Mayor Orcutt responded the construction documents are being worked on and core samples being taken.

Mr. Mencini asked if there will be meetings with Councilmembers of streets in wards that need to be done in 2023?

Mayor Orcutt responded yes, as most people know there is a shortage of concrete and the last reason I heard is due to not having the necessary raw materials. Complimented the service director and city engineer for working diligently on another route for milling and filling. Prices have been gathered from companies that perform this type of work and meetings with Councilmembers will be scheduled.

Mr. Troyer asked for an update on the roof and walls (former natatorium center) at the recreation center?

Mayor Orcutt responded a purchase order has been created for the advertisement and will be going out bid and bringing those numbers back to Council.

Mr. Troyer continued with the roads and doing a full-depth will that be like Grosse with the asphalt in the center.

Mayor Orcutt responded if concrete repairs are needed they will get done.

#### Service Director Beyer

Mr. Beyer reported that bulk pickup is next week on regular scheduled rubbish day, mattresses must be wrapped. On Thursday, November 24th, Thanksgiving Day, the department is closed so rubbish pickup will be delayed one day, Thursday pickup on Friday and Friday pickup on Saturday. This is the last week for yard waste and rubbish drop off at the service department Monday through Friday. The department is trying a new program beginning December 3rd with staying open on Saturdays only from 9:00 a.m. to 1:00 p.m. for yard waste and rubbish drop off. With leaf pickup crews are getting through the city approximately every ten (10) days.

#### **Engineer Piatak**

Mr. Piatak reported the Snow Road demolition project is continuing with asphalt and paver removal operations, there have been some setbacks with equipment break down. With the Delores Blvd. three residents requested trees that were planted. With the Wedo Park retention basin details are being finalized for the design and hydraulics analysis. The Geo test report is underway and I didn't see a lot of organics or unsuitable materials. With Mr. Troyer's statement about Grosse Drive with the asphalt center that was a curb and gutter repair and there are many pros and cons with this type of repair that also takes longer time for completion; there is a pavement repair method that the city is considering.
