Due to not speaking clearly into microphone, unable to decipher the four other residents from Switzer Road that expressed concerns with a business expansion on Apollo Drive.

Liz Sayers 23065 Cedar Point Road

Ms. Sayers expressed safety concerns at Brook Park Elementary School traffic.

Mayor Orcutt stated he is aware of the information given that manufacturing, warehouse and truck activity is coming to Apollo Drive. The building was just purchased and the new owner submitted an application to the Planning Commission for aesthetic project approval; all construction documents are sent to the building commissioner for determination. If outside of the U-6 zoning requirements the owner will have to go to the Planning Commission for a Conditional Use Permit, residents will be able to speak at that meeting. If the Planning Commission approves the Conditional Use Permit it is then forwarded to City Council. To Ms. Sayers the plan is to install a traffic signal for children to cross from the school to the recreation center parking lot for pickup.

Mr. Mencini stated he thought the issue with the school would be handled through the school board and people from Audrey's Outreach and police officers have directed traffic. To the west-end residents I understand you don't want that type of business there and will go along with the Mayor as to what it is going to occur, our job is to protect residents.

Mr. Poindexter stated to the Switzer Road residents he found out after the Planning Commission meeting about the expansion and has received calls. That area is not an industrial area it is a U-6 zone for Research & Development or office space. The new owner intends to change th use of the building and that is not right when it is not zoned for that. It's not only unfair to the residents in the area but it's also unfair to the new building owner because he made an investment when purchasing that building.

Addressing the audience: cont.

Mr. Troyer stated with the no standing signs, Council passes the laws but does not enforce them; that is the Administration. With the business expansion I spoke with two people and have received calls. How do you give aesthetic approval with no variance and what the trees will look like? Should have had a Conditional Use Permit first and asked Mayor Orcutt if there will be a Conditional Use Permit?

Madam Coyne thanked all the residents for coming. To Ms. Sayers the Mayor is addressing the issue with the elementary school safety issue. To the west end resident's, I was not aware of anything until last week and have spoken with a few residents that received random letters. This is still in the process of coming together and I am as curious, as the residents. I Think this city is moving forward and needs to create jobs and businesses. It is disturbing when I hear residents may move and would not want any residents moving before anything happens. Also, have to trust the administration to provide information when they have it.

Mayor Orcutt stated to Mr. Troyer if the business owner so chooses to apply for a Conditional Use Permit the city would have to by law. When it comes to a business owner purchasing a building it is up to that business owner to do due diligence with the zoning of the area; if manufacturing then the owner would have to apply for a Conditional Use Permit. Referred to Mr. Beyer about the elementary school crosswalk.

Mr. Beyer stated to Ms. Sayers, there is a crosswalk there, unfortunately, it served both the former middle and elementary schools, different type of traffic. The Mayor submitted a work order to the service department for a crosswalk that is currently in the early stages. Would like to have a crosswalk from the recreation center parking lot to the Sandfield - Cambridge areas. Officer Kosakowski is currently looking into any grants and funding for the crosswalk.

Mr. Troyer stated to west-end residents I have the recordings of the Planning Commission meeting where the owner stated manufacturing with one (1) truck per hour per dock. The business owner and his attorney also stated that a Conditional Use Permit was not needed due to a few words in the U-6 zoning code and I am glad to hear there will be a Conditional Use Permit.

Southwest General Health Center Trustee, Mencini

Mr. Mencini reported with Covid-19 in volume 68,300 patients were tested with 9,500 testing positive; 254 deaths; 15-plus in-house patients increasing by 14% with volume to increase. Patients with the flu has a strong basis. Primary and special care campuses are located on Bagley Road in Middleburg Hts., Strongsville, Brecksville, and Olmsted Falls. Berea Board of Education Representative, Coyne

Madam Coyne reported the last meeting was held on December 12th and am in favor of the Shout-Out meetings that are very positive. Mayor Orcutt reported the Wedo Park retention soil testing is complete and have a meeting schedule with Ford Innovation Center to discuss the report, would be helpful if they can take the dirt. The construction documents are complete and will have something in February. The orange barrels by the amphitheater are for the new restrooms to be delivered in January; those monies were paid through county and state funding. The administration has been meeting with Councilmembers to discuss the roads program to include more side streets in 2023. Thanked all the employees for a wonderful 2022 and looking forward to 2023. Wished everyone Happy Holidays and Happy New Year.

REPORTS AND COMMUNICATIONS FROM DEPARTMENTS, COMMISSIONS, AND OTHER PUBLIC OFFICIALS:

Mr. Beyer reported that the department collected approximately 53-tons of bulk last week; will continue to keep the service yard open for waste drop off on Saturday's from 9:00 a.m. to 1:00 p.m., weather permitting. The CSX ditch-cleaning was completed last week and the city engineer is currently putting a contract and invoice together. The city received a \$250,000.00 maintenance grant for Holland Road, between Engle and Eastland Roads, for joint and maintenance repairs. To date the department cleaned 178 catch-basins, laid 172 more tons of asphalt, planted 16 trees and approximately had 627 hours with the street sweeper.

Law Director Horvath

Madam Horvath stated no report but have some remarks. The department has been short-handed last few weeks and thanked Clerk of Council, Carol Johnson, Council President Vecchio and Debby Doud for assistance with processing of legislation. Wished all city employees, Council, Mayor, Administration and residents a happy holiday season.
