Mayor Orcutt stated this gives the city ability to have an open purchase order with Westview Concrete for sidewalk replacement, road repairs, water main breaks and street repairs. With the three (3) different quotes listed this company was picked due to having the best scheduling, the other companies were not able to give delivery times first thing in the morning, making it more expensive with overtime and such.

Mr. Poindexter asked is there a guarantee of the materials required, don't foresee any shortages during the term of the concrete?

Mayor Orcutt responded don't see any shortage issues, this is just for repair work.

Mr. Mencini asked if there would be a delay would something possibly come back to the city.

Mayor Orcutt responded we had that problem last year and emergency legislation was brought forward due to concrete shortage. If that occurs again then legislation would be brought forward to Council.

Mr. Mencini continued the surcharges increased quite a bit but this company has good dealings with the city.

Mr. Troyer stated this is for 2023 for cement needs for this year?

Mayor Orcutt responded yes, just up to we may not spend all that and the sidewalk program funds itself.

Mr. Troyer asked Mr. Cingle if this has been appropriated yet?

Mr. Cingle responded will appear in the permanent appropriations.
