The meeting was called to order by Council President Vecchio at 7:00 p.m., the clerk called the roll and the following Members of Council answered:

Madam Horvath stated no objections with the liquor permit.

2. AN ORDINANCE AMENDING ORDINANCE 11323-2023 TO INCLUDE ELMDALE ROAD AND CYNTHIA DRIVE FROM FRY ROAD TO ROBERT DRIVE TO THE GENERAL PAVEMENT SERVICES PROGRAM AND DECLARING AN EMERGENCY. Introduced by Mayor Orcutt.

Mayor Orcutt stated the resurfacing of nine different areas in the city with Council appropriating \$1,420,000.00 have been completed at the cost of \$954,891.79; leaving a balance of \$465,108.21. Had a few other streets identified and after doing the math the city identified a portion of Cynthia Drive between Fry Road and Robert Drive that the city would like to do at a cost of \$145,635.84. Also, included is all Elmdale Road at a cost of \$281,230.84 adding these two streets to this year's roads program; the balance left over would be \$38,241.53 and ask through legislation to be put into the crack-sealing and joint repairs and municipal parking lot repair.

Mr. Mencini asked Mayor Orcutt on the streets identified is that due to price total or damage of streets; do have Stonecrest and Robert Drives in Ward 2, streets done good calls received.

Mayor Orcutt responded did have a few streets as well as the ones mentioned, there are many bad streets throughout the city. With the combination of monies

leftover is what made the determination. Elmdale is a secondary artery and in bad shape; last year three tons of hot-patch was used for potholes.

3. AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A COMMUNITY COST-SHARE AGREEMENT BY AND BETWEEN THE NORTHEAST OHIO REGIONAL SEWER DISTRICT (NEORSD) AND THE CITY OF BROOK PARK FOR A WEDO PARK RETENTION BASIN AND DECLARING AN EMERGENCY. Introduced by Mayor Orcutt.

Mayor Orcutt stated the cost of the retention basin is estimated at \$1,252,000.00 and this contract allows the city to pull from the community cost share account with the sewer district. End of July there was \$880,000.00 and the city is asking to utilize \$800,000.00. The allows the city to pay ourselves back at \$200,000.00 for the next five-years for a total of \$1 million-dollars; the community cost-share is over \$300,000.00 collected from taxpayers and businesses of Brook Park.

Mr. Troyer clarified the cost-share is 25% storm water management fee listed on sewer bill; 75% goes to the entity for major projects.

Motion by Mr. Scott, supported by Mr. Mencini, discussed.

Mayor Orcutt stated the economic development commissioner is applying for a grant for a senior transit van with a wheelchair lift. The vehicle currently being used is a re-purposed police vehicle for senior grocery shopping and doctor visits.

Mr. Mencini stated to Mayor Orcutt will this coincide with the service department of be a different entity, will there be another driver?

Mayor Orcutt responded same purpose and will replace the re-purposed police vehicle being used by the service department, bonus being the wheelchair lift.

Mr. Troyer stated this was announced at senior club a few weeks ago, seniors are all for it. Basically, a people hauler van with a wheelchair lift.

Mr. Mencini mentioned when rejected by Planning or Zoning there is a reason for it.

Mr. Vecchio stated if rejected by Planning or Zoning there is not Council-matic action.

Mr. Troyer stated looking at all paperwork draw attention 1121.34 - Conditional Use Permit. Public hearing on conditional use permit applications - 1121.341 c next regularly meeting Council shall approve or deny.

Mr. Vecchio concurred and stated if passed at Planning than Council can approve or deny, if not passed at Planning then it's non-existent.

Mr. Troyer understood that and stated there was an incident that the Planning Commission denied and it still came before Council. Asked Madam Horvath if denied by Planning Commission does not need to come before Council.

Madam Horvath responded yes, that is my understanding and why my answer to Mr. Mencini, that needs to be made clearer, so there isn't any doubt whatsoever and so the public has an understanding on how things work.

Mr. Troyer clarified if Planning Commission denies a conditional use permit, property on Engle Road, then it's done.

Both Mr. Vecchio and Madam Horvath concurred with that statement.

Mr. Vecchio stated serving on Planning commission in 2016-2017 it was that way if denied by Planning, did not move forward.

There being no further business to come before this meeting a **motion** by Mr. Troyer supported by Mr. Mencini, to adjourn.
