Mr. Troyer reported the commission met on September 11th, first item Conditional Use Permit was removed due to a denied zoning variance. Aesthetic approval to convert the former Burger King to Savvy Sliders at 14101 Snow Road passed; I voted no due to including a 20' monument sign in front, that is against city codes. A Conditional Use Permit was granted for a Gymnastics training facility at 2000 Apollo Drive. Aesthetic approval was granted for aesthetic approval of a storm water basin at PPN# 344-06-126 Wedo Park. A Conditional use permit was tabled for Albert Einstein.

Mr. Mencini stated with budget times starting would like to see a few things come up i.e. doorbell cameras, safety building and commercial parking enforced and getting done.

Mayor Orcutt responded absolutely, and the Air BNB piece you put out will be a key-role for the administration, law department and building department to be able to enforce that issue.

Mr. Poindexter thanked Mayor Orcutt for the recent conversation regarding LED lighting, look forward to working with you.

Mayor Orcutt responded look forward to working with you on this good project for the city to move forward, once completed will have an immediate return on the investment.

Mr. Troyer asked Mayor Orcutt to elaborate on the LED lighting conversation due to when the presentation was made I mentioned taking \$360,000.00 for city-wide lighting.

Mayor Orcutt responded what occurs is the service director will apply for the application and once approved the administration will bring legislation forward for city-wide lighting.

REPORTS AND COMMUNICATIONS FROM DEPARTMENTS, COMMISSIONS, AND OTHER PUBLIC OFFICIALS:

Recreation Center Program Coordinator Morgano

Madam Morgano reported the Boo Park festival will be held on Sunday, October 8th from 12:00 p.m. to 3:00 p.m. with hay rides, magic shows, petting zoos, contests and food trucks. The main gym floor and track will be closed from Thursday, September 21st through Friday, September 29th. Basketball registrations will begin on October 1st and the recreation center is taking applications for Adult Women's volleyball.

Service Director Beyer

Mr. Beyer reported Crossroads Asphalt started on Elmdale Road today, will do Cynthia Drive tomorrow and repairs to a few roads done earlier this year. Leaf season will begin soon. September 22nd is the deadline for the Sidewalk replacement program. C & J Contractors will be rock-hounding and reseeding the former Super 8 property this week.

Reports and communications from departments, commissions and other public officials: cont.

Engineer Piatak

Mr. Piatak reported with the Sheldon Road water line project detours were set up yesterday with pavement operations taking place today. With the Brook Park Memorial demolition project abatement work will continue through early October. The Wedo Park retention basin project hauling operations are continuing and it's estimated that approximately 20,000 yards of material has been removed, equating to 40%, with another 2 1/2 to 3 weeks of hauling to go.

Law Director Horvath

Madam Horvath reported there have been no changes to the case status on the city's pending litigation list. Would like to talk about a few changes that will be implemented on October 3rd to the Ohio Revised Code (ORC). Everyone knows that legislation, agendas and notices are posted at five different posting places throughout the city; pursuant to ORC 731.25. That section has been repealed by House Bill (HB) 33 eliminating the posting location options for municipalities. The new ORC section 731.21(a) gives three methods for posting of summaries for ordinances, resolutions and agendas. First being general circulation in a newspaper; second being posting on a city social media website per section 125.082 that does not seem possible and third and most viable for Brook Park would be posting on the city's website. Section 125.082 doesn't have the ability to post on a city social media website and posting in a newspaper can be quite expensive. The best option is to post on the city's website and the law department will be looking at ordinances and Council rules for moving of all postings to the city's website.

Mr. Modic gave an update on the Tri-City dog park there will be a ceremony on October 12th at 6:00 p.m. to name the pavilion after Carl Burgio. Expressed confusion with a sign variance given by the zoning board that is against the codes. The other issue is with the former Brookview Memorial Elementary school sale thinks good idea as long as Parkman Drive won't have traffic congestion, in that area.

Susan Schweter

5771 Somerdale Avenue

Madam Schweter expressed concerns with 61 new homes coming to her neighborhood, water coming out of those homes and experienced flooding twice this year. Also, Northeast sewer monies should be used for Brook Parks' sewer system hiring employees to get the jobs done. Brookgate shopping center looks awful.

Motion by Mr. Troyer, supported by Mr. Poindexter, to respond to the audience. **ROLL CALL: AYES:** Troyer, Poindexter, Roberts, Mencini, Scott, Coyne, Salvatore

Mr. Troyer stated to the gentleman that talked about Planning & Zoning meetings the sign was included in aesthetic approval and I disagreed and voted no. To Ms. Schweter the storm water management is a negative aspect that was put on the sewer bills; 100% goes to the sewer district and the city can only get 25% back. The program the Mayor is bringing forward will be for Brook Park, different from the storm water management.

Mr. Poindexter stated to Ms. Schweter the development at (former) Brookview school and north side of Snow Road any new development has to have negative water on the system. Should have some relief with the retention pond being installed on the north side of Snow Road and two retention ponds that the Mayor negotiated at the (former) Brookview school property. Brookgate (shopping center) is privately owned and until there is incentive it's up to them.

Mr. Mencini stated to Mr. Modic good move that the dog park pavilion being named after Carl Burgio. To Ms. Schweter the city helped the Brookgate owners to get a grant to remove the former BP gas station and when the owners attended a meeting they were told to pick up their game but they're happy. Have also heard that no one shops at Brookgate, going outside the city.

Mr. Roberts thanked Ms. Schweter for coming and stated that's why the grant was done for the former BP gas station demolition and the three retention basins. With Brookgate when I go into Marcs there are long lines at Marcs and Planet Fitness is

busy, so people do shop there. Can be made better and the city is trying but, as said, it's not always easy working with them.

Mayor Orcutt clarified any builders that come to Brook Park must put in a retention basin, to assist with the water. With the plans from the developer there will be a large retention basin at Van Wert and Snow Road. With the sewer fees most frontages in Brook Park are 60 feet so that's \$60.00, as an example. With shopping I hear from the residents would like more restaurants. Economic Development commissioner and myself speak with developers and they don't want to come to Brook Park based on demographics; to see the household income. The housing project put in front of City Council for the sale of the property will put higher-end rentals, \$1,500.00 to \$2,500.00 per month driving the demographics up.

Mr. Troyer commented should change the zoning, rather than a conditional use permit, zoning takes three readings.

Mayor Orcutt stated have been working with the law director, building commissioner and an outside consultant to look at those options. The way the property is zoned to go through with a conditional use permit will be looking at multiple variances that is much easier to deal with, rather than rezoning. The outside consultant is not costing the city any money.
