Mr. Vecchio stated items three (3) and four (4) are companion pieces.

Mr. Troyer stated the reason this came about is with the passage of the (recent) election at the state level. This will take time to make the rules but as of December 7th companies can get in line to come into the city, needs to be done prior to December 7th.

Madam Horvath this needs to be addressed as to how recreational and medical marijuana are sold in the city and will take a little time and study to get this done. Most important aspect with this is the zoning.

Mr. Poindexter stated colleague is correct if this is not limited to the two (2) zones for medical marijuana. By December 7th anyone can file for licensing in any zone of our city. My suggestion, voters spoke loud and clear at 65%, residents want but need to locate in zones for medical marijuana U-7 or U5-A zones

Mr. Vecchio stated in Section 1126.03 specifies U5-A and all U-7.

Madam Horvath stated looking at the City of Bexley their legislation only deals with zoning for recreational marijuana, law department will do everything possible to get this done.

Madam Coyne stated it would behoove Council to have Mr. Bryant come up and speak.

Mr. Mencini asked who is he, is he an expert or the person that selectively called Councilmembers, but not me?

Madam Coyne stated he has a dispensary on the corner of West 150th Street.

Discussion: cont.

Motion by Madam Coyne, supported by Mr. Troyer, to allow Mr. Wesley Bryant to speak.

ROLL CALL: AYES: Coyne, Troyer, Scott, Mencini, Roberts, Poindexter, Salvatore **NAYS:** Unanimous.

Mr. Bryant spoke before Council on recreational marijuana with a questions/answers segment that can be heard via livestream or placed on a flash drive from the Clerk of Council for a monumental charge, per the codified ordinances.

Mr. Mencini commented neither for or against it as long as it is done legally.

Mr. Roberts commented would be surprised how many people drive to Michigan on a regular basis; let's keep that money here and be proactive instead of reactive.

Motion by Mr. Troyer, supported by Mr. Roberts, to have law department amend both pieces of legislation to either read medical/recreational or remove medical whatever is best.

Mr. Vecchio clarified those amendments will be for both items three (3) and four (4).
