Parks & Recreation Committee - Chairman, Mencini

Mr. Mencini provided an update on the recreation membership with single (residents) - 478 non-residents - 136 total 614 and 350 monthly. Child residents - 62 and employees are low with four (4) residents and two (2). The senior memberships total 1,948.

Southwest General Health Center Trustee, Mencini

Mr. Mencini gave an update on Southwest General by stating it is a 354-bed hospital founded in 1920 and merged with University Hospital in 1997; level three (3) trauma center and primary stroke center. One annual report that Southwest follows shows many challenges facing Southwest such as growing employer, activism against transparency and high costs on many sectors as well as purchasing of activities and equipment. Growing hostility of not for profit hospitals, increase tension with providers, hospital groups and insurers.

INTRODUCTION OF RESOLUTIONS OF COMMENDATION:

REPORTS AND COMMUNICATIONS FROM THE MAYOR:

Mayor Orcutt welcomed a new police officer and firefighter. On November 24th the tree-lighting and parade ceremony were great events, many thanks to the recreation center, police and fire. There are five (5) pieces of legislation being introduced tonight. House Bill 23 has changes to the city's tax code before December 15th.

Mr. Troyer stated with the temporary budget the ADA compliance - \$50,000.00 appropriated has any monies been spent and give Council a list.

Mayor Orcutt responded may have spent some monies for a railing, fixing of sidewalks for wheelchair access. Those monies may not have come out of the ADA fund but one ticket item with ADA is the new playground equipment update or replacement - \$277,000.00 and looking into more grants for that project.

Mr. Troyer continued would like to see another \$50,000.00 appropriated in the budget.

Mr. Poindexter requested adding some moneys for rubbish cans for residents to buy.

Mayor Orcutt responded last year's budget did include new rubbish can and have heard that 20% of homes have a second can. Service crews have noticed that at certain homes contractors are disposing waste from their jobs by using the city's bulk program. New cans are available to new residents or to replace damaged cans.

Mr. Troyer stated trucks have cameras, there are laws and rules against certain materials.

Mayor Orcutt responded city would probably be dinged by Republic in Oberlin that is not the big issue. What is being seen is the same home, every month, having a tree lawn full of bulk, drywall and so forth.

REPORTS AND COMMUNICATIONS FROM DEPARTMENTS, COMMISSIONS, AND OTHER PUBLIC OFFICIALS:

Law Director Horvath

Madam Horvath reported with the Active Civil Litigation list, the first case being the City of Brook Park vs. City of Cleveland. City of Brook Park has filed notice of appeal responses on Monday; would expect in 90 days for that case to be definitive. With the State of Ohio vs. Pat Johnson and Mark Higgins, companion cases. The Supreme Court will most likely go forward first and disposed of. With the request for stay on the Common Pleas case probably won't know anything until the case management conference on January 16th. The new case listed is a foreclosure case, not typical, with this case the plaintiff sued the defendant and received a default judgement for a very large amount of money. Decided to foreclose on defendant's house that the city had a lien on the property.

Finance Director McGann

Mr. McGann reported working on November month-end reports.

Recreation Program Coordinator Morgano

Madam Morgano reported had a huge event over the weekend with the pancake breakfast having over 250 participants. Thanked everyone's who help including the recreation commissioner members. Letters to Santa are still being collected please put in the mailbox outside of the recreation center; if a reply letter is requested deadline date is December 17th, no envelope or postage required. Registrations are taking for holiday house decoration until December 26th.

Safety Director Sensel

Mr. Sensel welcomed new members to both police and fire departments. Engineer Piatak

Mr. Piatak reported with the Wedo Park basin concrete the concrete sidewalk, and curb work will be finishing up this week with few miscellaneous site items; then will wind down until spring. The Shelby Drive resurfacing project, north of Hummel, was resurfaced last week with the 2023 General Pavement contract. The Brook Park Memorial school demolition will continue until January or February, 2024. The Sheldon Water Main Project the asphalt base-course was done today with surface course being done tomorrow, may be some traffic congestion please avoid area if possible. Working with the Mayor and Service Director Beyer on some options for applications projects through the County Public Works for 2024 county road reimbursements, deadline date is December 13th.

Mr. Troyer stated to Mr. Piatak with the Wedo Park retention basin it is functionally operational, correct?

Mr. Piatak concurred.

Mr. Troyer stated section 2 needs to be increased to 32,500.00 of the second last page of the contract - reimbursable expenses.

Mayor Orcutt responded the discussion at the October 30th special meeting a request was made to include in the scope of work an outdoor pool. An email was sent to Council on November 6th that was red-lined to include outdoor pool.

Mr. Troyer continued don't see a rendering for the (natatorium) roof and walls.

Mayor Orcutt responded that rendering was put out in 2021.

Madam Coyne stated this proposal demonstrates necessity of why studies should have been done. A lot of items on this proposal are cosmetic and should be appropriated for in the 2024 budget. Also, proposes to re-image the city buildings and incorporate a new building/recreation center. Most alarming is priority three

Mr. Troyer - Point of Order

Mr. Vecchio recognized audience speaking unable to hear.

Madam Coyne continued with the safety center - recreation center a comprehensive study must be done in order to give Council viable options; planning strategies and funding plans to meet the needs of this city, also public input.

Mr. Poindexter stated comfortable passing as is and come back to Council later.

Mr. Troyer expressed concerns with the Gateway to the city at Snow Road and I-71 discusses a pump station; is there a pump station there?

Mayor Orcutt responded the gateway entrances to the city is Smith Road - West 150th Street rendering of a pump station.

Mr. Troyer expressed concerns with many things and agreed the (natatorium) roof and walls must be done. Using this to get monies is fine.

Mr. Mencini stated there a lot of items liked with this and there are a lot of issues with money but must start moving forward and make those tough decisions.

Mayor Orcutt stated this investment will be able to put projects forward, presentations to the Planning Commission and budgeted through Council for approval. Trying to build tools for a master plan to recreate the city. The safety building is extremely old and in need of many repairs.
