Mr. Dufour reported City of Cleveland purchased the former Cleveland Sheraton hotel in 2022 that will be demolished. Frontier Airlines is adding ten (10) additional destinations as of May, 2024.

Mr. Mencini reported next meeting March 5th.

Finance Committee - Scott

Mr. Scott reported two items on the agenda, Board of Control met earlier with 14 items on agenda; three (3) largest Road Salt - \$40,000.00; Gas & Diesel fuel - \$50,000.00 and three body cameras - \$22,605.00.

**REPORTS AND COMMUNICATIONS FROM THE MAYOR:**

Mayor Orcutt welcomed one (1) police officer sworn in a few weeks back and two (2) lateral transfers, thanked all police officers for keeping the community safe. Home Days celebration will be held the weekend of July 12th to July 14th with entertainment locked in for the entire weekend, more information in the upcoming spring newsletter. Thanked Winding River Construction Company for recent upgrades at four (4) park pavilions. Thanked Brook Park Boosters for a wonderful fundraiser and all monies raised at the fundraisers are turned back to the community. Four (4) summer concerts will be held on Fridays in the months of June through September that the Brook Park boosters sponsor, organize and pay for.

**Questions to the Mayor:**

Mr. Troyer asked Mayor Orcutt with Home Days will fireworks be held on Sunday.

Mayor Orcutt responded Orcutt yes talked to have on Saturday not available lot of requests.

Mr. Roberts asked about an update on the budget, when will Council have?

Mayor Orcutt responded the budget was going to be introduced this evening, but with last week's recent ruling from the Ohio Supreme Court regarding House Bill (HB) 157, the budget had to be readjusted, on the positive side for Brook Park.

Mr. Poindexter asked for an update on the former Brookview school sale for potential homes

Mayor Orcutt responded the company did the abatement testing and things of that nature. The March Planning Commission and Board of Zoning agenda will have all the plans for rezoning and necessary items. The company is hoping to break ground on Pemberton after all necessary approval in Summer, 2024.

Mr. Mencini asked about the safety zone at the police station; doorbell cameras and commercial parking that have been put to the side, possibly being implemented.

Mayor Orcutt responded with the commercial vehicle parking there is an ordinance on the books regarding tonnage so that has been addressed. The video zone is in the budget and it was found out with putting together the equipment the components are not compatible, so the company owner is working on a network for that to be compatible.

Mr. Troyer asked will the former Brookview school will be rezoned?

Mayor Orcutt concurred and stated easiest way to move forward, lot involved.

**REPORTS AND COMMUNICATIONS FROM DEPARTMENTS, COMMISSIONS, AND OTHER PUBLIC OFFICIALS:**

Law Director Horvath

Madam Horvath reported with HB 157 rebates, good news for the city. On March 11th there will be the first (1st) case management conference for the City of Brook Park vs. City of Cleveland (airport deal). Working with co-counsel on the best strategies that will be successful for the city.



**Reports and communications from other departments, commissions and public officials: cont.****Recreation Program Coordinator Mendoza**

Madam Mendoza reported the Daddy-Daughter dance was a huge success, as stated. The next big event is Spring into Park to be held on Saturday, March 23rd. Deadline for spring basketball is March 10th and Flag Football is March 1st.

**Finance Director McGann**

Mr. McGann reported last Wednesday with a 5-2 decision the Ohio Supreme Court ruled that the with the 2020 pandemic the legitimate interest was insuring that municipal incomes remain stable for employees working from home, therefore, the budget needed to be changed due to this ruling and will have next meeting.

**Service Director Beyer**

Mr. Beyer reported American Legion structure received a new roof; both the pavilion and bathroom at McGovern Park received new roofs, the pavilion at Cavanaugh Park and Plant Lane bathroom received new roofs. All work done by Winding River Construction and all materials donated by Owens Corning, no cost to the city. Led conversions on Snow Road 13 heads have been replaced between former hotel and Route 237, north side. With the yard being open on Saturdays from 9:00 a.m. to 1:00 p.m. there are times the yard must be closed for the safety of residents and employees.

**Engineer Piatak**

Mr. Piatak reported the former Brook Park Memorial School (BPM) demolition project will wrap up by end of the week; contractor will come back in the spring to install topsoil and finish grading. Wedo Park activity last week the fence contractor installed the split rail along the basin and cell tower.

**Questions:**

Mr. Poindexter asked Mr. McGann with the HB157 ruling does that only affect refunds for this year or for past refunds.

Mr. McGann responded involves 2020 work from home refunds, that we were told to put money aside until the ruling.

Mr. Poindexter to Mr. Beyer is there a date for the garage opening permanently?

Mr. Beyer responded April 8th, will be mention in the spring newsletter.

Mr. Mencini to Mr. Beyer with the warm weather noticed holes being patched?

Mr. Beyer responded crews are cold-patching holes; the asphalt plant won't open until mid-April.

Mr. Mencini asked if any other projects are being done to catch up before spring weather?

**Questions to the directors: cont.**

Mr. Beyer responded yes, there were eight (8) water breaks with four (4) being poured Thursday and four (4) being poured Friday. Mid-March, weather permitting, will start to dismantle Kennedy Park (playground equipment) for installation of new equipment.

Mr. Mencini asked Madam Mendoza let the staff know great job, much appreciated.

Mr. Troyer stated to Mr. Beyer received a complaint about the Holland Road (railroad) tracks any idea when they will be done?

Mr. Beyer responded believe those were done within the last five (5) to ten (10) years don't think there is anything on the radar.

Mr. Troyer asked Mr. Beyer to check on that, not good for city vehicles. With the service garage closed on Saturday when snow falls the snow is the main focus of the crews. Is that true if service crews are needed somewhere else during the summer months also?

Mr. Beyer responded very rare that the service yard is closed during the spring, summer or fall months, not saying that couldn't happen.

Mr. Troyer to Madam Horvath have the Cleveland Airport affected residents been notified of recent status?

Madam Horvath responded a short letter was mailed out today to those residents.

Mr. Troyer to Mr. McGann owe you an apology for not understanding what was said last week. With the HB157 court case, the reason the city received those monies is because money was set aside by the city; remember \$1.6 million-dollars. What was the total amount of monies?

Mr. McGann responded roughly \$1 million-dollars.

Mr. Troyer stated to Mr. Piatak people are misunderstanding the Wedo Park retention/detention basin; that collects water from mostly Ashland Drive, Harrison Drive and Shelby Drive, north of Hummel.

Mr. Piatak concurred.

Mr. Troyer continued nothing on the other side of Hummel Road but in certain circumstances that water is being diverted to the Kolleda Ditch.



**Questions to the directors: cont.**

Mr. Piatak responded correct about drainage areas some of Ashland and Harrison comes down to smith. That water goes to the basin and is stored in the basin, allowing water from the south side of Hummel Road being diverted to Kolleda Ditch.

Mr. Dufour asked Madam Mendoza any thought of doing something for the eclipse in April?

Madam Mendoza responded a watch party could be considered.

Mr. Dufour to Mr. Beyer last meeting there was mention of a grant for a second (2nd) salt storage dome?

Mr. Beyer responded with the last snowstorm it allowed room to take the last snow in the contract.

Mr. Peterlin expressed concerns energy savings project having no subcontractors, First Energy kilowatt service and wind generator.

Mr. Poindexter stated wind turbines were brought up to former Mayor Gammella in 2019 and first item on the Technology agenda. The potential site would be I-71 and Snow Road a few hurdles was with Ohio Department of Transportation, infield and airport; then came down to money. With the wattage the city is now paying \$0.7 a kilowatt saving the city \$100,000.00 annually.

Mr. Dufour stated two (2) incrementally improvement and what steps need to be overcome, with funding being one of them.

Mayor Orcutt stated the idea of a structural engineer is one that is welcomed and are currently moving forward with second opinion for the roof and walls. The text mentioned that there is no warranty on the roof is incorrect, there is a warranty.

Mr. Dufour asked Mr. McGann how much is to be collected?

Mr. McGann responded approximately \$90,000.00.

Mr. Dufour read Article four (4) section three (3) of the agreement and asked what circumstances that action would be taken

Mr. McGann responded discussion with the law firm if a taxpayer owes \$20,000.00 the city is looking at collecting 90%.

Mr. Troyer stated to Mr. McGann there are different fees and scenarios in this so with passage the city will get everything owed to them?

Mr. McGann responded correct, any fines or attorney fees are passed onto the taxpayer.

The clerk called the roll on the motion to adopt.
