INTRODUCTION OF NEW LEGISLATION:**

New Legislation:

1. AN ORDINANCE AMENDING SECTION 141.02 OF THE BROOK PARK CODIFIED ORDINANCES ENTITLED 'COMPOSITION: EXECUTIVE HEAD; AND DECLARING AN EMERGENCY. Introduced by Mayor Orcutt.

Motion by Mr. Dufour, supported by Mr. McCorkle, to move to letter M-1.

SECOND READING OF ORDINANCES AND RESOLUTIONS:

1. ORDINANCE NO. 11542-2026
DETERMINING THAT THE ESTABLISHMENT OF THE BROOK PARK NEW COMMUNITY AUTHORITY WILL BE CONDUCTIVE TO THE PUBLIC SAFETY, CONVENIENCE AND WELFARE AND IS INTENDED TO RESULT IN THE DEVELOPMENT OF A NEW COMMUNITY AND DECLARING THE NEW COMMUNITY AUTHORITY TO BE ORGANIZED AND A BODY POLITIC AND CORPORATE AND DEFINING THE BOUNDARY OF THE NEW COMMUNITY DISTRICT' APPOINTING BOARD MEMBERS AND APPROVED RELATED MATTERS. Introduced by Mayor Orcutt.

Mayor Orcutt clarified this is new, never been done before, but simplified by saying this is to form the New Community Authority (NCA). This piece of legislation must have three (3) readings like rezoning of property; with a public hearing to be held on July 15th at 6:00 p.m. The intent is to have consideration of a New Community Authority on July 15th for approval.

Mr. Salvatore stated Ordinance No. 11542-2026 has had its second reading.

Mayor Orcutt clarified this legislation is for the sufficiency of a petition filed with the city by the Haslam Sports Group to create the New Community Authority (NCA).

NAYS: Unanimous. Adopted.

Mayor Orcutt thanked City Council for approval of sufficiency of the NCA.

Mr. Mencini thanked Mayor Orcutt and administration for the hard work and time involved in this matter.

There being no further business to come before this meeting a **motion** by Mr. Mencini, supported by Mr. Dufour, to adjourn. Members of Council voted AYE.

Council President Salvatore declared this meeting adjourned at 6:35 p.m.
