## AN ORDINANCE

AUTHORIZING THE MAYOR TO TRADE-IN THE CITY'S JOHN DEERE ROTARY AND HUSTLER SUPER Z MOWERS, AND DECLARING AN EMERGENCY

SECTION 1: The Mayor is hereby authorized to trade-in a John Deere Mower and a Hustler Super Z Mower.

<u>SECTION 2</u>: The trade-in value of the John Deere Mower is \$1,000.00 and the Hustler Super Z is \$500.00, and the quote for the trade in allowance is attached hereto and incorporated herein as Exhibit "A".

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
