INTRODUCED BY: MAYOR GAMMELLA, COUNCILMAN TROYER AND C/W

AN ORDINANCE  
AUTHORIZING THE MAYOR TO ENTER INTO A  
CONTRACT WITH SUTPHEN CORPORATION,  
FOR THE PURCHASE OF A CUSTOM PUMPER FIRE TRUCK,  
AND DECLARING AN EMERGENCY

WHEREAS, the City of Brook Park's Fire Department's pumper truck is a 1986 model, with a life expectancy of twenty years; and

WHEREAS, this vehicle is well past its life expectancy, and needs to be replaced for the safety and security of Brook Park's residents; and

WHEREAS, this contract with Sutphen Corporation must be entered into by July 31, 2021 or the price will increase substantially.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The Mayor is hereby authorized to enter into a contract, with Sutphen Corporation, for the purchase of a new Sutphen custom pumper fire truck as listed on the Sourcewell Contract # 8022818 SUT, which is further described in Exhibit "A" (quote).

SECTION 2: The money needed for the aforesaid transaction shall be paid from Fund No. 401, Capital Fund; theretofore appropriated or to be appropriated for said purpose.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that

resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to allow the City to purchase a new Sutphen custom pumper fire truck; therefore provided this ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
