AN ORDINANCE AUTHORIZING  
THE MAYOR TO ADVERTISE FOR BIDS FOR TREE ARBORIST PLANTING  
SERVICES, AND FURTHER AUTHORIZING THE MAYOR TO ENTER INTO A  
CONTRACT WITH THE LOWEST AND/OR BEST BIDDER, AND DECLARING AN  
EMERGENCY

WHEREAS, the City of Brook Park applied for a grant with the county of Cuyahoga for a Healthy Tree Canopy Program and was awarded a grant in the amount of \$50,000.00; and

WHEREAS, said grant has been approved for the Brook Park Urban Forestry Management and City Center Tree Plan.

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The Mayor is hereby authorized to advertise for bids for tree arborist planting services, and the Mayor is further authorized to enter into a contract with the lowest and/or best bidder for said contract, not to exceed \$20,000.00.

SECTION 2: The money needed for the aforesaid transaction shall be paid from Fund No. 100, General Fund; in the total amount appropriated or to be appropriated for said purpose.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
