AN ORDINANCE  
AUTHORIZING THE MAYOR TO ENTER INTO A CHANGE ORDER  
BETWEEN SIGNAL SERVICE, AND THE CITY OF BROOK PARK  
FOR ADDITIONAL MAINTENANCE AND REPAIR WORK TO OUR TRAFFIC SIGNALS  
INCURRED UNDER ORDINANCE 11161-2020,  
AND DECLARING AN EMERGENCY

WHEREAS, Ordinance No. 11161-2020 passed on September 1, 2020 authorized Signal Service Company to provide for maintenance of traffic control devices in an amount not to exceed \$40,000.00;

WHEREAS, said maintenance and repairs to our traffic signals has exceeded \$40,000.00 requiring an increase in expenditure authority by \$65,000.00 for a total of \$105,000.00.

NOW THEREFORE BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

**SECTION 1:** The Finance Director is hereby authorized and directed to pay Signal Service Company a total sum of not more than \$105,000.00 from the general fund 100.

**SECTION 2:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3:** This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to enter into a change order with Signal Service Company; provided this ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
