## AN ORDINANCE

AUTHORIZING THE MAYOR TO TRADE-IN THE CITY'S 2013 HUSTLER HYPERDRIVE 72 INCH MOWER, AND PURCHASE A NEW 72 INCH HUSTLER SUPER Z MOWER AND FLEX FORKS AND DECLARING AN EMERGENCY

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

- **SECTION 1:** The Mayor is hereby authorized to trade-in a 2013 Hustler Hyperdrive 72 inch mower.
- **SECTION 2:** The trade-in value of the mower is \$1,600.00 and the quote for the trade in allowance is attached hereto and incorporated herein as Exhibit "A".
- SECTION 3: The Mayor is hereby authorized to enter into a contract with Baker Vehicle Systems, through Sourcewell contract #031121-HTE for a new Hustler Super Z HyperDrive mower for a price not to exceed \$13,166.00, and flex forks for \$296.00 as further illustrated in Exhibit "A".
- SECTION 4: The money needed for the aforesaid transaction shall be paid from fund 401-342 (Capital), and shall not exceed \$11,862.00 (\$13,462.00 less \$1,600.00 trade-in).
- SECTION 5: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 6: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and authorizing the

Mayor to trade in a mower, purchase a new mower and flex forks, therefore, provided this ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
