AN ORDINANCE ESTABLISHING A NEW SPECIAL REVENUE FUND TO BE KNOWN AS THE ONEOHIO SETTLEMENT FUND, NO. 276, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brook Park, Ohio:

SECTION 1. That, pursuant to the provisions of the Ohio Revised Code (ORC) Section 5705.09(F) and the City's Home Rule authority, there shall be and is hereby established a Special Revenue Fund known as the "OneOhio Settlement Fund No. 276" to be utilized by the Director of Finance to account for distributions to be received from the State of Ohio, as well as allowable expenditures, consistent with the City's participation in the OneOhio Memorandum of Understanding resulting from the National Opioid Settlement Agreement and litigation.

SECTION 2. That further pursuant to the provisions of Chapter 5705 of the ORC and the City's Home Rule authority, the City's Fund structure shall be restated and amended to reflect the addition of such new Fund No. 276 - the OneOhio Settlement Fund.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

SECTION 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, and for the further reason to establish the OneOhio Settlement Fund, therefore
