AN ORDINANCE ESTABLISHING THE AMERICAN RESCUE PLAN FUND, AND DECLARING AN EMERGENCY.

WHEREAS, the City has received its portion of funds from the American Rescue Plan Act Fund; and

WHEREAS, the Director of Finance requests a fund be created for administration of the funds received from the American Rescue Plan Act Fund.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brook Park, Ohio:

SECTION 1. The Finance Director is authorized and directed to create a special revenue fund, designated the American Rescue Plan Act Fund (Fund 282), for the purpose of receiving and expending monies from said fund, as a special revenue fund to separately account for revenues and expenditures associated with the fund.

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, and for the further reason to establish the American Rescue Plan Fund, therefore provided this Ordinance receives the affirmative vote of at least five (5) members elected to Council it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
