AN ORDINANCE

AMENDING SECTION 123.01

OF THE BROOK PARK CODIFIED ORDINANCES, ENTITLED 'POSTING PLACES,'

AND DECLARING AN EMERGENCY.

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: Section 123.01 of the Brook Park Codified Ordinances, passed by Ordinance No. 4338-1975, passed August 12, 1975; Resolution No. 33-1960, passed November 1, 1960; and Ordinance No. 6228-1982, passed November 1, 1982, amended by Ordinance 10049-2016, passed November 1, 2016 and reading as follows:

123.01 POSTING PLACES.

- (a) The following locations in the City are hereby determined to be the five most public places and are hereby designated as the posting places for all resolutions, ordinances, notices and other matters required by law or ordinance to be published:
 - (1) City Hall, 6161 Engle Road
 - (2) Police Station, 17401 Holland Road
 - (3) Fire Station No. 2, 22530 Ruple Road
 - (4) Fire Station, 17401 Holland Road
 - (5) Brook Park Library, 6155 Engle Road
- (b) The Council Clerk is hereby directed to post all ordinances, resolutions, notices, proclamations, statements, orders and reports required by law or ordinance to be published at the aforesaid locations in the City and on the City Council's website.
 - (c) Agenda.
 - (1) The Clerk of Council is hereby directed to post a copy of the agenda for all regular Council Meetings, seventy-two hours prior to a scheduled meeting, at the five most public places in the City as designated in subsection (a) and on City Council's website.

123.01 POSTING PLACES.

- (a) Pursuant Section 731.21(A)(3) of the Ohio Revised Code, all matters required to be posted, including all municipal resolutions, ordinances, notices, statements, orders, proclamations, reports required by law to be published shall be published on the web site and social media account of the City of Brook Park.
- (b) The Clerk of Council is hereby directed to post a copy of the agenda for all regular Council Meetings, seventy-two hours prior to a scheduled meeting, on the web site and social media account of the City of Brook Park.
- **SECTION 2:** Former Section 123.01 of the Brook Park Codified Ordinances, as passed by Ordinance No. 4338-1975, passed August 12, 1975; Resolution No. 33-1960, passed November 1, 1960; and Ordinance No. 6228-1982, passed November 1, 1982, amended November 1, 2016 is hereby expressly repealed.
- SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of public peace, health, safety and welfare of said City, and for the further reason to amend Section 123.01 of the Brook Park Codified Ordinances therefore provided this Ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.

(1) The Clerk of Council is hereby directed to post a copy of the agenda for all regular Council Meetings, seventy-two hours prior to a scheduled meeting, at the six most public places in the City as designated in subsection (a) hereof and on City Council's website.

Section 731.21 | Publication of ordinances and resolutions.

Ohio Revised Code / Title 7 Municipal Corporations / Chapter 731 Organization

Effective: October 3, 2023 Latest Legislation: House Bill 33 - 135th General Assembly

- (A) A succinct summary of each municipal ordinance or resolution and all statements, orders, proclamations, notices, and reports required by law or ordinance to be published shall be published using at least one of the following methods:
- (1) In a newspaper of general circulation in the municipal corporation;
- (2) On the official public notice web site established under section 125.182 of the Revised Code;
- (3) On the web site and social media account of the municipal corporation.

Proof of the publication shall be made by affidavit of the proprietor of the newspaper or operator of the official public notice web site, as applicable, and shall be filed with the clerk of the legislative authority.

- (B) The publication shall contain notice that the complete text of each such ordinance or resolution may be obtained or viewed at the office of the clerk of the legislative authority of the municipal corporation and may be viewed at any other location designated by the legislative authority of the municipal corporation. The city director of law, village solicitor, or other chief legal officer of the municipal corporation shall review the summary of an ordinance or resolution published under this section before forwarding it to the clerk for publication, to ensure that the summary is legally accurate and sufficient.
- (C) Upon publication of a summary of an ordinance or resolution in accordance with this section, the clerk of the legislative authority shall supply a copy of the complete text of each such ordinance or resolution to any person, upon request, and may charge a reasonable fee, set by the legislative authority, for each copy supplied. The clerk shall post a copy of the text at the clerk's office and at every other location designated by the legislative authority.
