AN ORDINANCE

AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH

MANHEIM CLEVELAND AUTO AUCTION, PUBLIC AUCTIONEERS,

FOR THE PURPOSE OF AUCTIONING FORFEITED VEHICLES AND A POLICE

VEHICLE THAT IS NO LONGER IN SERVICE, AND DECLARING AN EMERGENCY

WHEREAS, Manheim Cleveland Auto Auction will provide the City of Brook Park with Auction services for three forfeited vehicles; a 2008 Mazda MCX CX7, a 2001 Chevrolet K15, a 2012 GMC, and a 2008 Ford Crown Victoria Police Car that is no longer in service; and

WHEREAS, Manheim Cleveland Auto Auction will charge the City of Brook Park a selling fee of \$100.00 per auctioned vehicle; and

WHEREAS, it is in the best interest of the City of Brook Park that said agreement be entered into;

NOW THEREFORE BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

- **SECTION 1:** The Mayor is hereby authorized and directed to enter into an agreement with Manheim Cleveland Auto Auction, for the purpose of disposing of forfeited vehicles, a list of which is attached hereto and incorporated herein as Exhibit "A" at a public sale.
- **SECTION 2:** The money needed for the aforesaid transaction shall be paid from the Law Enforcement Fund 270, theretofore appropriated for said purpose.
- **SECTION 3:** Proceeds from the sale shall be deposited into Law Enforcement Fund 270 and Capital Fund 401.
- SECTION 4: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that

resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to provide for an agreement between Manheim Cleveland Auto Auction and the City of Brook Park; therefore provided this ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.


