AN ORDINANCE AMENDING ORDINANCE 11453-2025  
TO INCLUDE ADDITIONAL ROADWAY REPAIRS IN THE 2025 GENERAL  
PAVEMENT SERVICES PROGRAM,  
AND DECLARING AN EMERGENCY


NOW THEREFORE, BE IT ORDAINED by the Council of the City of  
Brook Park, State of Ohio, that:

**SECTION 1:** The 2025 General Pavement Services Program) shall be amended  
to include the items listed on Exhibit "D", which is attached hereto and incorporated  
herein.

**SECTION 2:** The money needed to complete the aforesaid transaction shall be  
paid from Fund Nos. 240 and 551, SCM&R and 2025 Street Improvements Funds,  
theretofore appropriated or to be appropriated for said purpose.

**SECTION 3:** It is found and determined that all formal actions of this Council  
concerning and relating to the adoption of this Ordinance were adopted in an open  
meeting of this Council, and that all deliberations of this Council and of any of its  
committees that resulted in such formal action were in meetings open to the public in  
compliance with all legal requirements, including Section 121.22 of the Ohio Revised  
Code.

**SECTION 4:** This Ordinance is hereby declared to be an emergency measure  
necessary for the immediate preservation of the public peace, health, safety of said City,  
and for the further reason that City Council deems it necessary to proceed with the 2025  
General Pavement Services Program as soon as possible, therefore, provided this  
Ordinance receives the affirmative vote of at least five (5) members elected to Council, it  
shall take effect and be in force immediately from and after its passage and approval by  
the Mayor; otherwise, from and after the earliest period allowed by law.
