ORDINANCE NO: 11518-2024

INTRODUCED BY: MAYOR ORCUTT

AN ORDINANCE AMENDING ORDINANCE 11449-2024, PASSED DECEMBER 17, 2024, WHICH AUTHORIZED THE MAYOR TO HIRE THE LAW FIRM OF "BRICKER GRAYDON LLP", TO ACT AS CO-COUNSEL WITH THE LAW DIRECTOR, DUE TO A NAME CHANGE OF THE FIRM TO "BRICKER GRAYDON WYATT LLP", AND DECLARING AN EMERGENCY

WHEREAS, the law firm retained as Bricker Graydon LLP, has changed their firm's name, and is now known as Bricker Graydon Wyatt LLP; and


WHEREAS, the Finance Department has determined that it is necessary to amend Ordinance 11449-2024, passed December 17, 2024, in order to pay invoices for legal work the firm has done on the City of Brook Park's behalf.

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: Ordinance 11449-2024, passed December 17, 2024, is hereby amended to reflect that the law firm Bricker Graydon LLP is now known as Bricker Graydon Wyatt LLP.

SECTION 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to amend Ordinance 11449-2024 to reflect the law firm's name change to Bricker Graydon Wyatt LLP from Bricker Graydon LLP; therefore provided this Ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
