AN ORDINANCE
AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH
BEST EQUIPMENT CO., INC., FOR THE
LEASE/PURCHASE OF ONE NEW 2019 MACK CHASSIS
WITH A 32 YARD LEACH REAR LOADER BODY,
AND DECLARING AN EMERGENCY

WHEREAS, the Mayor has determined that the Service Department for the City is in need of one new 2019 Mack chassis with a 32 yard leach rear loader body to help maintain our City; and

WHEREAS, the City of Brook Park is a member of the National Joint Powers Alliance ("NJPA") now known as Sourcewell which is an organization that creates national cooperative contract purchasing solutions for its member agencies; has competitively bid, advertised, and awarded the contract; and

WHEREAS, Best Equipment Co., Inc., is an Ohio truck equipment vendor that has been authorized by the NJPA, now doing business as Sourcewell, to provide trucks and truck equipment to NJPA members now doing business as Sourcewell.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: Pursuant to Section 7.04(h) of the Charter of the City of Brook Park, the Mayor is authorized to enter into an Agreement with Best Equipment Co., Inc., for the lease/purchase of one new 2019 Mack chassis with a 32 yard leach rear loader body; a proposal for said truck with chassis and equipment is attached hereto and incorporated herein as Exhibit "A."

SECTION 2: The money needed for the aforesaid transaction shall be paid from funds theretofore appropriated or to be appropriated for said lease/purchase of one new Mack chassis with a 32 yard leach rear loader body; the total amount of the purchase of said is \$227,615.00, and to be paid from capital fund 401 and sanitation equipment fund 423.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to allow the City to lease/purchase one new Mack chassis with a 32 yard leach rear loader body; provided this ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
