AN ORDINANCE

AUTHORIZING THE MAYOR TO ENTER INTO A CHANGE ORDER
BETWEEN CUSTOMIZED PHONE SYSTEMS AND THE CITY OF BROOK PARK
FOR ADDITIONAL RE-ROUTING AND WIRING AT THE
NEW BROOK PARK CITY HALL,
AND DECLARING AN EMERGENCY

WHEREAS, a Performance Contract and Service Agreement between the City of Brook Park and Customized Phone Systems was entered into on January 4, 2018; and

WHEREAS, said Service Agreement provided that Customized Phone Systems was to perform services for the City of Brook Park; and

WHEREAS, there is a need to amend the Service Agreement with Customized Phone Systems to make changes in plans to include additional rerouting and wiring at the new Brook Park City Hall; and

NOW THEREFORE BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The Finance Director is hereby authorized to pay the Customized Phone Systems for a change order as listed in Exhibit "A," attached hereto for the new Brook Park City Hall.

SECTION 2: The money needed for the aforesaid transaction shall be paid from the capital improvement fund 401 therefore appropriated or to be appropriated for said purpose in the amount of \$957.50.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to enter into a change order for Customized Phone Systems, Inc.; provided this ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
