AN ORDINANCE
AMENDING SECTION 141.02 (a)
OF THE BROOK PARK CODIFIED ORDINANCES
ENTITLED 'COMPOSITION: EXECUTIVE HEAD,'
AND DECLARING AN EMERGENCY

WHEREAS, there is a need to correct section 141.02(a) due to a scrivener's error; and

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: Section 141.02(a) of the Codified Ordinances of the City of Brook Park is hereby amended to read as follows:

141.02 COMPOSITION; EXECUTIVE HEAD.

(a) The Police Department shall consist of a Police Chief and not less **more** than forty-three regular police officers.

SECTION 2: Former Section 141.02 of the Brook Park Codified Ordinances as enacted by Ordinance No. 2650-1966, passed November 1, 1966, Ordinance No. 5715-1980 passed March 4, 1980, Ordinance No. 8664-2000, passed April 18, 2000, Ordinance 9621-2009, passed October 20, 2009, are hereby expressly repealed.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION: 4 This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason of amending Section 141.02(a) of the Brook Park Codified Ordinances; therefore, provided this ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its

Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
