AN ORDINANCE

AUTHORIZING THE MAYOR TO HIRE A CONSULTING FIRM TO PERFORM A COMPREHENSIVE STUDY TO PREPARE PLANS AND SPECIFICATIONS FOR WORK TO BE PERFORMED ON THE NATATORIUM ROOF AND WALLS, AND DECLARING AN EMERGENCY

WHEREAS, the roof and walls of the Natatorium are in desperate need of repair; and

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: Authorization is given to the Mayor to hire a consulting firm to perform a comprehensive study to prepare plans and specifications for work to be performed on the natatorium roof and walls.

SECTION 2: Such comprehensive study will be for a vapor barrier and without a vapor barrier.

SECTION 3: Such comprehensive study will also include lowering the current roof.

SECTION 4: The money needed for the aforesaid transaction shall be paid from funds theretofore appropriated for said purpose.

SECTION 5: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 6: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to determine the costs and optimal method to repair the Natatorium walls and roof, therefore this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
