INTRODUCED BY: MAYOR GAMMELLA

AN ORDINANCE  
AUTHORIZING THE MAYOR TO ENTER INTO AN  
AGREEMENT WITH AMBULANCE MEDICAL BILLING (AMB),  
AND DECLARING AN EMERGENCY

WHEREAS, Council deems it necessary for the City to enter into an agreement with a specialist in order to provide for certain information technology services related to ambulance billing and collection fees; and

WHEREAS, the Mayor as acting Safety Director and Fire Chief received bids from three vendors for said ambulance billing services; and

WHEREAS, the lowest and best bidder was Ambulance Medical Billing, hereinafter "AMB", who will provide computers, software and training in addition to the ambulance billing services.

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: That the Mayor is hereby authorized and directed to enter into an agreement with AMB, for the City's billing and collection of ambulance fees.

SECTION 2: The money needed for the aforesaid transaction shall be paid from General Fund 100 theretofore appropriated for said purposes.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to enter into an agreement with AMB for ambulance billing services; provided this ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
