AN ORDINANCE
TERMINATING THE RETENTION AND EMPLOYMENT
OF THE LAW FIRM OF GARY C. JOHNSON & ASSOCIATES, LLC,
AND DECLARING AN EMERGENCY

WHEREAS, the City of Brook Park may employ consultants and attorneys to provide professional and legal services; and

WHEREAS, the City no longer wants Gary C. Johnson, LLC, to provide professional and legal services to the City; and

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: That the retention and employment of the law firm of Gary C. Johnson & Associates, LLC shall be terminated on the effective date of this Ordinance and that no monetary funds of the City of Brook Park shall be paid to such law firm for any work or services provided subsequent to the effective date of this Ordinance.

SECTION 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason that the City is involved in legal matters requiring the immediate substitution of counsel; therefore, this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
