AN ORDINANCE  
AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY  
TO PREPARE SPECIFICATIONS AND FURTHER AUTHORIZING  
THE MAYOR TO ADVERTISE FOR BIDS AND TO  
ENTER INTO AN AGREEMENT OR AGREEMENTS WITH THE LOWEST AND/OR  
BEST BIDDER TO PROVIDE TOWING SERVICES FOR THE CITY,  
AND DECLARING AN EMERGENCY

WHEREAS, the City presently has no formal agreement for the provision of towing services for the various Departments within the City; and

WHEREAS, said agreement or agreements would facilitate the regular and orderly procurement of towing services whenever required by the various municipal agencies.

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The Director of Public Safety is hereby authorized to acquire proposals for the provision of said towing services.

SECTION 2: The Mayor is hereby authorized to advertise for bids and to enter into a contract with the lowest and/or best bidder for same.

SECTION 3: The money needed for the aforesaid transaction shall be paid from funds theretofore appropriated for said purpose.

SECTION 4: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 5:** This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to provide for usual and ordinary operation of the City's Safety Department; therefore this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
