AN ORDINANCE
AUTHORIZING THE MAYOR TO HIRE THE LAW FIRM OF
KAUFMAN & COMPANY TO
ACT AS CO-COUNSEL WITH THE LAW DIRECTOR
AND DECLARING AN EMERGENCY

WHEREAS, the City of Brook Park may employ attorneys to provide professional and legal services, acting as co-counsel with the Law Director; and

WHEREAS, in accordance with Section 131.12 of the Brook Park Codified Ordinances, the Mayor upon the approval of Council, may procure the services of other legal professionals to act as co-counsel with the City of Brook Park's Law Director; and

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The Mayor is hereby authorized to procure the legal services of the law firm of Kaufman & Company for the purpose of assisting the Law Director.

SECTION 2: The money needed for the aforesaid transaction shall be paid from funds theretofore appropriated for said purposes.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason hire the law firm of Kaufman & Company; therefore

this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
