AN ORDINANCE  
AUTHORIZING THE MAYOR TO HIRE AN INSPECTOR  
FOR THE 2015 SIDEWALK REPAIR PROGRAM  
AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The Mayor be and is hereby authorized to hire an inspector for the 2015 Sidewalk Repair Program. The Inspector shall report to and be directed by the Consulting Engineer.

SECTION 2: The Inspector shall be paid between \$18.00 and \$23.00 per hour. Such payment to be made by the City upon receipt of statements from the Inspectors.

SECTION 3: The money needed to complete the aforesaid transaction shall be paid from funds theretofore appropriated or to be appropriated for said purpose.

SECTION 4: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the City, and for the further of the immediate need to have an Inspector on site for the duration of the project; therefore, this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
