AN ORDINANCE  
AUTHORIZING THE MAYOR TO ENTER INTO AN  
AGREEMENT WITH TCC TECHNOLOGY SOLUTIONS  
WITHOUT PUBLIC BIDDING, TO PROVIDE FOR THE  
IT SUPPORT AND DATA BACK UP SERVICES FOR THE CITY,  
AND DECLARING AN EMERGENCY

WHEREAS, the City is in need of continued internet, computer, network technical support, data backup, a disaster recovery program and installation of IT services

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

**SECTION 1:** Pursuant to Section 7.04(h) of the Charter of the City of Brook Park, the Mayor is hereby authorized to enter into an agreement with TCC Technology Solutions which is needed for internet, computer, network technical support, data backup a disaster recovery program and installation of IT services for the City of Brook Park.

**SECTION 2:** The money needed for the aforesaid transaction shall be paid from funds theretofore appropriated or to be appropriated for said purpose, but shall not exceed \$67,000.00.

**SECTION 3:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason for the City of Brook Park to maintain their

internet, computer, network technical support, data backup and a disaster recovery program with TCC Technology Solutions; therefore, this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
