INTRODUCED BY: COUNCIL AS A WHOLE

A RESOLUTION APPROVING THE AESTHETICS AND CONSTRUCTION OF THE  
AMPHITHEATER STRUCTURE ON THE CITY OF BROOK PARK'S PROPERTY  
AND DECLARING AN EMERGENCY

WHEREAS, on August 11, 2021 the Planning Commission approved and referred to Council a request for the project and aesthetic approval for the construction of an amphitheater structure on the City of Brook Park property, PPN 343-16-001A, located at 6161 Engle Road in the Municipal and Board of Education Zone.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The amphitheater project approved by the Planning Commission on August 11, 2021 is hereby authorized and approved by the Council of the City of Brook Park and is further shown in Exhibit "A".

SECTION 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to approve this amphitheater project; therefore, provided this ordinance receives the affirmative vote of at least five (5) members elected to Council. It shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
