A RESOLUTION  
DESIGNATING THE MONTH OF FEBRUARY  
AS HEART HEALTH AWARENESS MONTH IN THE CITY OF BROOK PARK,  
AND DECLARING AN EMERGENCY

WHEREAS, more than 120 million American live with a cardiovascular condition; and

WHEREAS, Heart disease has long been the leading cause of death in the United States, claiming nearly 700,000 lives a year; nearly half of all American adults have at least one major risk factor for cardiovascular disease; and

WHEREAS, from heart attacks and strokes to high blood pressure, the threat of cardiovascular disease touches almost every family in our Nation; and

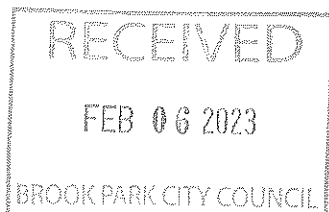
WHEREAS, while heart conditions can be costly and deadly, they are also often preventable with access to affordable health care and lifestyle changes; stop smoking, exercise regularly, manage your weight, and learn the warning signs of a heart attack or stroke and seek medical care immediately..

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Brook Park, State of Ohio that:

SECTION 1: That this Council does hereby designate the month of February as Heart Health Awareness Month in Brook Park.

SECTION 2: It is found and determined that all formal actions of this Council concerning and relating to this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


SECTION 3: This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of


