A RESOLUTION  
IN SUPPORT OF THE PASSAGE OF THE  
HEALTH CENTER RENEWAL LEVY,  
AND DECLARING AN EMERGENCY

WHEREAS, Southwest General Health Center serves this community with its hospital facilities; and

WHEREAS, the question of a renewal tax levy will be submitted to the electors of this City on November 7, 2023.

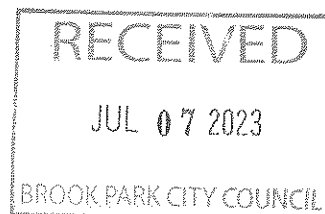
NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BROOK PARK, COUNTY OF CUYAHOGA AND STATE OF OHIO:

SECTION 1. That this Council hereby supports and urges all residents to vote in favor of the Southwest General Health Center three-tenths (.30) of a mill renewal levy.

SECTION 2. That the Clerk be and is hereby directed to forward a certified copy of this Resolution to Southwest General Health Center, attention: William A. Young, President and Chief Executive Officer.

SECTION 3. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

SECTION 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, and for the further reason to support the passage of the Southwest General Health Center Renewal Levy; therefore, provided this Resolution receives the affirmative vote of at least (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
