INTRODUCED BY: COUNCIL AS A WHOLE

A RESOLUTION GRANTING THE CONDITIONAL USE PERMIT TO OPERATE A MINI WAREHOUSE/STORAGE UNIT FACILITY, AT 15300 BROOKPARK ROAD, LOCATED IN THE U7-C DISTRICT, AND DECLARING AN EMERGENCY

WHEREAS, on May 3, 2021, the Planning Commission approved and referred to Council a request for a Conditional Use Permit to operate a warehouse/storage unit facility, with black ornamental fencing to be installed along Brook Park Road frontage as a condition at 15300 Brookpark Road located in the U7-C District.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The Conditional Use Permit to operate a mini warehouse/storage unit facility at 15300 Brookpark Road, located in the U7-C District, with the condition that black ornamental fencing be installed along the Brook Park Road frontage, approved by the Planning Commission on May 3, 2021, is hereby authorized and approved by the Council of the City of Brook Park.

SECTION 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to approve this Conditional Use Permit; therefore, provided this ordinance receives the affirmative vote of at least five (5) members elected to Council. It shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
