A RESOLUTION
RECOGNIZING THE MONTH OF MAY AS NATIONAL MILITARY
APPRECIATION MONTH IN BROOK PARK
AND DECLARING AN EMERGENCY

WHEREAS; Since 1999 the month of May is recognized in the United States as National Military Appreciation Month and is intended to honor those who have previously served, along with those who are currently serving to protect the freedoms of our great Nation; and

WHEREAS; Approximately 1.3 million men and women serve within the 5 Active Duty military branches; and

WHEREAS; Approximately 807,000 men and women serve within the 7 Reserve Duty military branches; and

WHEREAS; Brook Park, Ohio is home to the 3rd Battalion, 25th Marine Regiment; and

WHEREAS; Brook Park, Ohio is home to the Ohio Army National Guard 112th Engineer Battalion; and

WHEREAS; Without the selflessness exuded by our military members past and present we would not be able to enjoy the freedoms we have; and

WHEREAS; It is appropriate that we continue to recognize and underscore the needed support and encouragement community, family and friends lend to the commitment and strength of those members; and

WHEREAS; We encourage all residents to take the time to recognize those that have and are currently serving our country and to genuinely convey their appreciation for their patriotism by any gesture they deem appropriate. A simple phone call, message, handshake, or thank you can go a long way in showing our appreciation for their sacrifices.

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Brook Park, State of Ohio that:

SECTION 1: This Council along with the Mayor does hereby recognize the month of May, as National Military Appreciation Month in the City of Brook Park.

SECTION 2: This Council shall recognize National Military Appreciation Month at the first regularly scheduled meeting of the Council of the whole in the month of May by reading, into record this resolution.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 if the Ohio Revised Code.

SECTION 4: This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City and to show support by declaring the month of May as National Military Appreciation Month in the City of Brook Park; therefore, provided that this Resolution receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
