HONORING ST. STEPHEN ROMAN CATHOLIC CHURCH  
ON THEIR 150<sup>TH</sup> ANNIVERSARY,  
AND DECLARING AN EMERGENCY

**WHEREAS**, St. Stephen Roman Catholic Church is a national historic landmark, founded in April of 1869; and

**WHEREAS**, St. Stephen Roman Catholic Church is located at 1930 West 54<sup>th</sup> Street in Cleveland, Ohio and is celebrating their 150<sup>th</sup> Anniversary; and

**WHEREAS**, residents from the City of Brook Park often attend St. Stephen's Roman Catholic Church; and

**WHEREAS**, St. Stephen's offers masses in English, German and Latin; and

**WHEREAS**, on May 17, 2019 St. Stephen's is having a fundraiser Gala at the Intercontinental Hotel from 6:00p.m. to 10:30p.m., to help defray the cost for their 150<sup>th</sup> Anniversary Julibee Celebration Planned for September 21, 2019; and

**NOW THEREFORE BE IT RESOLVED**, by the Council of the City of Brook Park, State of Ohio that:

**SECTION 1:** The Mayor and Council of the City of Brook Park hereby wish to honor and congratulate St. Stephen's Roman Catholic Church on their 150<sup>th</sup> Anniversary.

**SECTION 2:** The Clerk of Council is hereby authorized and instructed to forward certified copy of this Resolution to St. Stephen Roman Catholic Church.

**SECTION 4:** It is found and determined that all formal actions of this Council concerning and relating to this Resolution were

adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 5:** This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to congratulate St. Stephen Roman Catholic Church on celebrating their 150<sup>th</sup> Anniversary, provided that that this Resolution receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
