## A RESOLUTION

GRANTING A CONDITIONAL USE PERMIT TO
CONSTRUCT AND MAINTAIN A TWO FAMILY DWELLING AT
6091 SMITH ROAD, LOCATED IN THE U1-A5 ZONE,
AND DECLARING AN EMERGENCY

WHEREAS, Ericka Bogdan filed an application for a conditional use permit with the Brook Park Planning Commission; and

WHEREAS, the conditional use requested is to construct and maintain a two family dwelling at 6091 Smith Road located in the U1-A5 Zone; and

WHEREAS, the request for a conditional use permit was presented at a public hearing on September 11, 2017 to the Brook Park Planning Commission, which referred this matter to Council for approval and recommended the waiver of requirements set forth in Section 1121.36(c) of the Brook Park Codified Ordinances.

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Brook Park, State of Ohio that:

**SECTION 1:** The Council of the City of Brook Park finds that the proposed conditional use permit requested is appropriate in the location for which it is proposed and hereby grants the conditional use permit, if the following specific conditions are met:

- A. Separate driveway and garage to be provided for each unit.
- B. Utilizing the existing storm connection and sanitary connection to service the proposed home as recommended by City Engineer.
- C. Proposed basement must be serviced by existing storm connection and sanitary connection.
- D. Variance will be required for size of proposed garage.

SECTION 2: It is found and determined that all formal actions of this Council concerning and relating to this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further purpose of granting a conditional use permit to construct and maintain a two family dwelling; therefore provided this Resolution receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
