A RESOLUTION
AUTHORIZING AND DIRECTING THE PLACEMENT OF A
"PURPLE HEART VETERAN" PARKING SPACE
IN ALL MUNICIPAL PARKING LOTS

WHEREAS, the Purple Heart is specifically awarded to members of the United States Armed Forces who have been wounded or paid the ultimate sacrifice in combat with a declared enemy of the United States of America; and

WHEREAS, the Council and the Administration of the City of Brook Park would like to show recognition to veterans who are recipients of the Purple Heart Award; and

WHEREAS, to honor the Purple Heart Veterans the City of Brook Park will provide an appropriately marked parking space for recipients of the Purple Heart Award and provide signage for exclusive parking spots in all municipally owned parking lots as a small gesture of recognition, appreciation and support of our Armed Forces and especially Purple Heart Veterans;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Brook Park, State of Ohio that:

SECTION 1: The Mayor is hereby authorized and directed to designate a parking spot in each municipally owned parking lot especially for Purple Heart Veteran and that such parking spot be painted and marked with appropriate signage reflecting the exclusive parking space for Purple Heart Veterans.

SECTION 2: The Clerk of Council is hereby authorized and instructed to forward a certified copy of this Resolution to be posted on the City's website.

SECTION 3: It is found and determined that all formal actions

deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Resolution shall take effect and be in force from and after the earliest time allowed by law.
