A RESOLUTION  
GRANTING A CONDITIONAL USE PERMIT TO  
OPERATE CUI SERVICES AT  
15314 BROOKPARK ROAD IN A U7-B DISTRICT,  
AND DECLARING AN EMERGENCY

WHEREAS, CUI Services has filed an application for a conditional use permit with the Brook Park Planning Commission; and

WHEREAS, the conditional use requested is to permit CUI Services to operate a landscape service business at 15314 Brookpark Road in a U7-B District; and

WHEREAS, the request for a conditional use permit was presented at a public hearing on September 14, 2015, to the Brook Park Planning Commission, which referred this matter to Council with certain conditions for approval and recommended the waiver of requirements set forth in Section 1121.36(c) of the Brook Park Codified Ordinances.

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Brook Park, State of Ohio that:

SECTION 1: The Council of the City of Brook Park finds that the proposed conditional use permit requested is appropriate in the location for which it is proposed and grants a conditional use permit to operate CUI Services at 15314 Brookpark Road.

SECTION 2: The granting of said conditional use permit is subject to the following conditions:

- a. The proposed work shall conform to the requirements established in Chapter 920 of the Brook Park Codified Ordinances.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to this Resolution were adopted

in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further purpose of granting a conditional use permit to operate a landscape services business in a U7-B district; therefore, this Resolution shall take effect and be in force immediately from and after its passage and approval by the Mayor.
